The Terms of Reference shall be as specified in the tripartite Memorandum of Agreement (MoA), Memorandum of Association (MoA) of the IMC Society and its Rules & Regulations.

The term of office of the IMC shall be three years from the date of issue of this notification or till the re-constitution of the IMC whichever is later.

The General Body of the Society shall be composed of members of the Governing Council together with such persons, from public and private bodies and individuals of ability or experience, subscribing to the aims and objects of the Society as may be nominated by the Governing Council and approved by the State Government, provided, however, that it will also be open for the State Government to nominate any individual as a member of the Society.


The affairs of the Society shall be administered, directed and controlled by a Governing Council in accordance with its Rules and Regulations and the members of the Governing Council shall become ipso facto members of the Society on their admission. The members of the Governing Council shall not be less than and more than 11.

The IMC shall meet as frequently as required and in any case at least once in a month. A member will have to intimate to the Chairman about his inability to attend the meeting on genuine grounds and obtain leave of absence. Any member remaining absent for three consecutive meetings without leave of absence shall cease to be member of the IMC from the date of third consecutive absence.

The non-official members, who attend the meeting shall be paid a fixed honorarium of Rs. 1500/- per meeting and no other TA/DA shall be payable.
