INTRODUCTION

DIRECTORATE GENERAL OF TRAINING (D.G.T.)

The Directorate General of Training (D.G.T.), New Delhi in the Ministry of Skill Development and Entrepreneurship is the apex organization for development and coordination at the National level for the programmes related to vocational training. There are about 15,000 Industrial Training Institutes (I.T.I.s) under D.G.T. across the country imparting vocational training.

The Craftsmen Training Scheme (C.T.S.) is the flagship scheme of D.G.T. for training of skilled craftsmen and is implemented through Government and Private Industrial Training Institutes (I.T.I.s) which are under the administrative and financial control of the State Governments or Union Territory administration. The I.T.I.s impart training in 150 Trades/courses which includes 82 Engineering trades, 63 Non-Engineering Trades and 05 trades for Persons with Disabilities (PwD)/ Divyangjan, all of which are NSQF compliant. Duration of these training courses varies from 6 months to 2 years.

A provision for supplementing the skills learnt during the I.T.I. training is also available in the form of workplace training through the Apprenticeship Training Scheme (ATS). One of the prime objectives of this scheme is optimal utilization of the infrastructural facilities available in the industry, where the apprenticeship training actually takes place, hence meeting the requirement of skilled manpower for industry.

Apart from above schemes, D.G.T. with an objective to strengthen Industry connect and impart industry relevant training to I.T.I. aspirants has introduced the Dual System of Training (D.S.T.) model wherein the I.T.I.s are being encouraged to join hands with multiple industry partners for providing mandatory industrial exposure to the trainees during the course of their training. Hence, a part of their skill training takes place in the industry environment.

INDUSTRIAL TRAINING INSTITUTES (I.T.I.S) IN GOA

There are 10 Government and 03 Private I.T.I.s in the State of Goa imparting training in various Engineering and Non-engineering trades/courses suitable to

the Indian and Goan industrial environment. Most of the trades and units available in these Institutes are affiliated to the National Council for Vocational Training (N.C.V.T.), New Delhi which is under the aegis of Directorate General of Training (D.G.T.), Ministry of Skill Development and Entrepreneurship (M.S.D.E.), Government of India, New Delhi and training is imparted as per the syllabus approved by Government of India in consultation with N.C.V.T. However, some of the trades/units in these I.T.I.s are affiliated to the State Council for Vocational Training (S.C.V.T.), Panaji-Goa and training in these trades/courses is imparted by following the same training and examination pattern, calendar, schedule and syllabi approved by D.G.T. and M.S.D.E.; only examinations are conducted and certificates issued at the State level.

INFRASTRUCTURE

Every I.T.I. has full-fledged workshops and classrooms to impart training, library, office, separate washrooms for male and female staff and trainees, drinking water facility and other basic necessities required in an Institution as per the prescribed norms of the Government. Apart from the regular training setup, many Government I.T.I.s are provided with Science, Technology, Engineering and Mathematics (STEM) Tinkering Labs, Digital Language Labs and CCTV cameras for surveillance. The Tinkering labs are useful for the I.T.I. trainees as well as the school students who visit the I.T.I.s to upgrade their knowledge and skills.

GRADING OF I.T.I.s

The D.G.T. has introduced a new Data Driven Grading Methodology (DDGM) for grading of I.T.I.s based on the performance of the I.T.I.s derived from parameters available on the N.C.V.T. portal. As per this, the I.T.I.s having a score of 4 and above (on a scale of 1 to 10) will be eligible for addition of new units/trades. The grading score is based on criteria like admission percentage, pass percentage, and gender diversity, etc. in the I.T.I. in the past few years. Accordingly, this grading methodology is dynamic and can change over subsequent years based on the performance of the I.T.I.s in the previous years. In the year 2024, the Government I.T.I.s in Goa have scored grades in the range of 6.2 to 8.3.

INSTITUTE MANAGEMENT COMMITTEE (I.M.C.)

As per the instructions and guidelines issued by D.G.T., every Government I.T.I. has an active Institute Management Committee consisting of industry partners/members, Director (SD&E) or his/her representative, Principal, faculty and a student representative of respective I.T.I. as its members. The Chairman and the other industry members being either entrepreneur or executive of an

industry, play an important role in sharing their knowledge and experience from the industry with the Department and the I.T.I. Their guidance to the Institute staff and trainees on upgradation of their knowledge and skills in par with the latest technologies and industry requirements helps the I.T.I. Instructors and trainees to understand the efforts required to be put by them in order to meet the industry requirement and improve placements of I.T.I. trainees. Some of the industry members donate tools and equipments useful for training to the I.T.I., bear expenses towards some infrastructural needs of the Institute and help in organizing workshops/programmes/seminars/industry visits for the I.T.I. Instructors and trainees under the respective company's CSR activity.

DIFFERENT TRAINING SCHEMES OF D.S.D.E.

1) Craftsmen Training Scheme (C.T.S.)

This is the flagship scheme of D.G.T. as well as the Department under which training is imparted in 44 different courses/trades at the Government and Private Industrial Training Institutes (I.T.I.s). The main objective of this scheme is to ensure steady flow of skilled personnel to the public and private sectors, and to reduce unemployment amongst the educated youth by equipping them with required skills, education and discipline.

2) Upgradation of 1396 Government I.T.I.s through Public Private Partnership (PPP)

This scheme was started by D.G.T. with an objective of improving the quality of vocational training in the country and making it demand driven so as to ensure better employability of the I.T.I. Graduates. In Goa, Vasco Government I.T.I. has been upgraded under the P.P.P. scheme with Paradeep Phosphates Ltd (PPL) (previously Zuari Agro Chemicals Ltd.) as its main Industry Partner. The Institute Management Committee (I.M.C.) headed by the Industry Partner and constituted and registered as a Society has been leading the up-gradation process of Vasco Govt. I.T.I.

3) Dual System of Training (D.S.T.)

The objective of D.S.T. scheme is to enable industries and establishments to partner with Government and Private I.T.I.s for conducting training programmes under high employability courses so as to fulfill their manpower requirements.

The dual system of training is an amalgamation of theoretical training imparted through I.T.I.s and practical training imparted through industry to the I.T.I. trainees so as to gain hands-on experience in the industry in using latest/updated technologies and understanding the actual industry working environment. Under this scheme, courses are conducted to meet the skilled

workforce requirement of industries so that after completion of training, the trainees who are awarded the National Trade Certificate (NTC) under the scheme have an edge over regular I.T.I. pass-outs in terms of employability and employment opportunities in the industry.

4) Production Oriented Training Scheme (POTS)

Under this scheme, all the Government I.T.I.s are allowed to offer various public utility services like maintenance, repairs and servicing of machinery, equipment and domestic appliances to the public on chargeable basis. The I.T.I. trainees under the guidance of their Instructors are permitted to take up short duration work assignments/jobs related to the trade they are undergoing training under the "Earn while you Learn" concept by following due procedures.

5) Chief Minister's Kaushalya Path Scheme (CMKPS)

The Chief Minister's Kaushalya Path Scheme (CMKPS) is implemented with an intention to equip a large number of Goan youth with industry relevant skills through skilling, re-skilling and up-skilling programs for narrowing the gap between demand and supply of skilled workforce in the State of Goa. The scheme focuses on short term training courses that cater to the specific needs of various sectors like Hospitality, Tourism, Construction, I.T., Automotive, Beauty & Wellness, Shipbuilding, Pharmaceutical, etc.

Additionally, it offers Recognition of Prior Learning (RPL) for experienced professionals. This component assesses and certifies the skills of individuals working in various sectors without formal qualifications, acknowledging their expertise and bridging the gap between their practical experience and formal recognition.

By focusing on these diverse skill areas and offering both training and RPL, the CMKPS aims to create a readily employable and skilled workforce that meets the demands of industrial sector of Goa.

6) Pradhan Mantri Kaushal VikasYojana (PMKVY)

The main objective of this scheme which basically offers short-term, skill certification courses was to enable large number of Indian youth to take up industry—relevant skill-training(s) which could help them to secure better livelihoods.

The PMKVY-Version 1.0, 2.0 and 3.0 of the scheme, have however, since been closed for implementation and accordingly, all its training, assessment and certification related activities have also been now formally concluded.

Further, the next version of this Scheme i.e.: PMKVY 4.0 stands re-classified as purely 'Centrally Sponsored, Centrally Managed (CSCM)' Scheme with the National Skill Development Corporation (N.S.D.C.) being designated as the Central Nodal Agency (CNA) to oversee its implementation during the coming years.

7) Skills Acquisition and Knowledge Awareness for Livelihood Project (SANKALP):

SANKALP programme of M.S.D.E. was started with loan assistance from the World Bank. Its aim was to improve short-term training qualitatively and quantitatively by strengthening institution, bringing in better market connectivity and inclusion of marginalized section of the society. The sharing pattern of the scheme is 60:40 (GoI:State).

8) Apprenticeship Training Scheme (ATS) under Apprentices Act, 1961:

Apprenticeship training is one of the most efficient ways to develop skilled manpower for public as well as private sector establishments by using existing training facilities in the establishments without putting any extra burden on the Government or industry's exchequer to set up special training infrastructure. The candidates completing apprenticeship training are able to easily adapt to the work/industrial environment at the time of regular employment.

A few details about the Apprentices Act, 1961 are as mentioned below:

Apprenticeship Act 1961

The Apprentices Act, 1961 was enacted with the objective of regulating the program of training of apprentices in the industry by utilizing the facilities available therein for imparting on-the-job training. Ministry of Skill Development and Entrepreneurship is the administrative ministry responsible for implementation of the Act.

The Government has brought comprehensive amendments in the Act in December 2014 to make it more attractive for both, the industry as well as the youth. Major changes introduced in the amendment were: replacing the outdated system of trade-wise and unit-wise regulation of apprentices with a band of 2.5% to 15% of the total workforce (including contractual workers), introducing optional trades, removing stringent clauses like imprisonment and allowing industries to out-source basic training.

Following are the two sub-schemes/policy under the main scheme:

a) National Apprenticeship Promotion Scheme – (NAPS-2)

The objectives of this scheme are as follows:

- (i) To develop skilled workforce for the economy by promotion of on-the-job experiential training.
- (ii) To encourage establishments to enroll apprentices by sharing partial stipend support to the apprentices.
- (iii) To provide up-skilling opportunities for candidates who have undergone shortterm skill training offered by various Central and State Government initiatives.
- (iv) To encourage enrolment of apprentices in small establishments especially Micro, Small and Medium Enterprises (MSMEs), and those located in the underserved areas such as aspirational districts and North-East Region.

Funding support under NAPS-2

- (i) Partial stipend support by GoI under NAPS-2 will be limited to 25% of stipend paid up to a maximum of Rs. 1,500/- per month, per apprentice during the training period.
- (ii) The stipend support by GoI will be paid through Direct Benefit Transfer (DBT) to the bank account of apprentices
- (iii) No stipend support will be available under NAPS-2 to the Central and State Government Departments and Central and State Public Sector Undertakings/Enterprises, including Public Sector Banks.

b) Goa Chief Minister's Apprenticeship Policy for Government Establishments-2023

Goa Chief Minister's Apprenticeship Policy for Government Establishments - 2023 was launched on 20th June 2023 for Goa Government establishments with an objective of increasing the employability of the youth of Goa and to encourage participation of Government establishments and Public sector in line with Apprenticeship Training Scheme for those youth having fifteen years residence in Goa.

Goa has become the first State to implement Apprenticeship Policy to cover maximum State Government Departments / Establishments.

Minimum stipend ranging from Rs. 8000/- to Rs. 13000/- per month is paid to apprentices depending upon the educational qualification which is over and

above the minimum stipend rates stated under Apprenticeship Act 1961 and Apprenticeship rules. Through this policy the apprentices have been provided on-job-training in real work environment which has enhanced the employability of the Goan youth.

INFORMATION PERTAINING TO LONG-TERM TRADES/COURSES OFFERED UNDER C.T.S. IN GOVERNMENT AND PRIVATE I.T.I.s

A candidate willing to join any of the course available in the I.T.I.s may take admission as a Regular Trainee or as a Private Candidate. In case a candidate wants to pursue a course as a Regular Trainee, he/she may take admission in a Government or a Private I.T.I. However, if a candidate wants to take admission in specific course as a Private Candidate, he/she may take admission strictly in a Government I.T.I.

B. <u>ADMISSION AS A REGULAR TRAINEE:</u>

Admission related information such as age, standard of physical fitness, residence period, reservation of seats, method of selection, caution money deposit and other applicable fees to be paid, concessions, transport facility, working hours, leaves & holidays, etc. are published in the Prospectus of the respective year, which is available online. A common Prospectus is published for both, Government and Private I.T.I.s by the Directorate.

The Directorate has implemented online admission system from the Academic Year 2020-21 onwards for admitting candidates in C.T.S. courses/trades. This facility enables interested candidate to apply for admission to I.T.I. from anywhere across the globe, provided he/she meets the eligibility criteria.

 - c. Children of African Repatriates of Goan Origin (CAR)

- (iii) One seat in each of the I.T.I.s are reserved for wards of defense personnel in the following order of priority:
 - a. Children of deceased/disabled Ex-Servicemen, including those killed/disabled during peacetime.
 - b. Children of Ex-servicemen
 - c. Children of serving Jawans
 - d. Children of serving Officers
 - e. Ex-Servicemen.

The allocation of trades is at the discretion of the Director (SD&E).

<u>The reservation shall be considered only if specifically indicated in the application</u> form by the candidate.

A refundable amount is required to paid as Caution Money Deposit (CMD) after admission to Government or Private I.T.I. as applicable.

If seeking admission in a Government I.T.I., a trainee is required to deposit a sum of Rs.1500/- (per Trade) to guard against any loss or damage caused to equipments or tools entrusted to him/her during the course of training. A second deposit may also be collected in case the first deposit amount has been exhausted.

If a trainee does not cause any loss or damage to the Institute, the CMD amount is refunded back to the trainee on completion of the trade/course.

4. Examination Fees:

A trainee declared eligible to appear for the annual/semester pattern All India/All Goa Trade Test (AITT/AGTT) of craftsmen under C.T.S. scheme conducted at the end of each year/semester is required to pay the following amount as examination fee:

E. EXAMINATIONS:

i. Internal Exams

Internal quarterly exams are conducted for Annual Pattern trades under C.T.S. Marks scored in above exams are considered for award of Formative Assessment marks.

ii. Annual Exams

Annual exams are conducted for the trainees seeking admission in various C.T.S. trades under the aegis of N.C.V.T./S.C.V.T. at the end of the respective Sessional/academic year or as declared in due course after completing the training as per syllabus of the first year. Similarly, second annual exam would

be conducted at the end of the second Sessional Year or as declared in due course after completing the training as per syllabus of second year. Trainees of two years duration trades can attempt 02 annual exams.

The All India Trade Test (AITT) examination pattern is also followed for the trades under S.C.V.T.AII the examinations would be conducted as per the norms applicable that may be revised from time-to-time.

F. TRADE CERTIFICATE ISSUED TO C.T.S. TRADE TRAINEES ADMITTED IN

i. National Council for Vocational Training (N.C.V.T.) Trades

On completion of the prescribed period of training, a trainee would have to undergo trade-testing based on the corresponding syllabus and a mark-sheet would be issued on appearing for the exam on completion of respective training period. Successful trainees will be awarded National Trade Certificate.

The N.C.V.T. registered trainees can access their academic progress online on Management Information System (N.C.V.T. MIS for annual system)/SIDH public portal using his/her personal credentials for logging into the MIS/SIDH portal and can download the mark sheet and trade certificate directly from N.C.V.T. MIS/SIDH portal www.skillindiadigital.gov.in which could also be verified online. The same is authentic document and is valid for submission for employment, admission, availing loan under MUDRA scheme, etc.

ii. State Council for Vocational Training (S.C.V.T.) Trades:

A trainee admitted under S.C.V.T. has to undergo examinations under S.C.V.T. For the trades and units under S.C.V.T., examinations and certifications will be conducted/issued as per applicable prevailing rules. However, the exam will be conducted by the State Board of Examinations and the certificates will be issued by the S.C.V.T.

ADMISSION AS A PRIVATE CANDIDATE

A candidate interested in obtaining I.T.I. certificate under respective course which has allocated percentage of vacant seats in the Government I.T.I.s should strictly approach any of the Government I.T.I.s in Goa to find details of the admission date/month and admission process, and then apply as a Private Candidate based on his/her eligibility for the respective trade/course as set by D.G.T. to enable him/her appear for the AITT on payment of applicable fees.

SCHOLARSHIPS:

The trainees of Government I.T.I.s are awarded the following scholarships:

- 1. **Merit scholarship** at the rate of Rs. 250/- per month per trainee is awarded to 40% of actually admitted trainees strength of each irrespective of the intake capacity of the trade on the basis of: (i) the marks scored at the Merit Scholarship internal test conducted by each I.T.I. (ii) assessment of the sessional work, discipline and punctuality three months after admission.
- 2. For the trainees seeking admission in Government I.T.I.s in Goa and residing in the State of Goa for a period not less than 10 years preceding the date of application for admission, following scheme is available as per eligibility:

<u>Financial Assistance Scholarship (FAS) and Trainee Tool Kit Scheme</u>:

Financial assistance at the rate of Rs. 600/- per month is available for a trainees belonging to either (i)BPL family OR (ii) Scheduled Caste Category OR (iii) Scheduled Tribes Category OR (iv) Persons with Disabilities (PwD) OR (v) having annual income of family less than Rs. 300,000/- which is to be proved by submitting Income Certificate issued by Competent Authority.

Trainee Tool Kit containing trade related items costing not more than Rs. 2500/collectively can be claimed by a trainee belonging to SC/ST category provided he/she fills up the Trainee Tool Kit form and submit to the I.T.I. along with supporting documents immediately after joining the respective I.T.I.

Direct Admissions to Second Year in Polytechnic Institutes

ACADEMIC EQUIVALENCE TO I.T.I. COURSES

- A. Goa Board of Secondary & Higher secondary Education in its meeting held on23/03/2016 has resolved to grant academic equivalence to I.T.I.'s N.C.V.T./S.C.V.T. courses subject to the following conditions:
- (1) Those students who after passing Std. VIII have completed a I.T.I. course of 2 years duration from a recognized center and passed N.C.V.T./S.C.V.T. examination with prescribed syllabus and on their own volition have appeared and passed the examination conducted by the Goa Board of Secondary and Higher Secondary education in the subjects: 1) Language—II 2) Language—II/ Language—III prescribed by the Goa Board shall be considered equivalent to have passed SSC Examination.
 - Students who complete a recognized a I.T.I. course of one year duration and complete one year apprenticeship training or certified employment will also be extended the same facility.
- (2) Those students who after passing Std X have completed a I.T.I. course of two years duration from a recognized center and passed N.C.V.T./S.C.V.T. examination will prescribed syllabus and on their own volition, have appeared and passed the examination conducted by the Goa Board of Secondary and Higher Secondary Education in the subjects 1) Language I Communication Skill in English 2) Language-II prescribed by the Goa Board shall be considered equivalent to have passed H.S.S.C examination.
 - For the above purpose the candidates have to register themselves as private candidate offering isolated subjects, who have passed SSC and completed I.T.I. fulfilling other conditions as laid down at (2) above.
- B. The Goa University grants vertical mobility to the Vocational Students of Goa Board and the same facility is extended to the students of I.T.I.s. The Academic Council of Goa university at its recent meeting resolved to permit mobility to students who, after passing Std X, having completed the I.T.I. Courses of two years duration which have Std X as the eligibility from recognized centers and pass the National/State Council of Vocational Training (N.C.V.T./S.C.V.T.) examinations of prescribed syllabus and on their own volition have appeared and passed the examination conducted by the Goa Board of Secondary and Higher Secondary Examination in the Subjects of English/Communication Skills for Std XII prescribed by the Goa Board.

The Eligibility for joining a particular program however would be decided based on earlier Circulars issued on the subject matter.

WORLD SKILL COMPETITION

World Skills Competition is the largest Skill Competition in the world held once every two years in one of the World Skill International (WSI) member countries. India has been member of World Skill since 2007. The competition is equivalent of Olympic Games for Skill amongst youth across world. There are about 56 Skills under six skill categories. Trainees compete over span of four days working on test projects which are based on contemporary Industry Standards and Infrastructure. World Skill India & India Skill is an initiative of the N.S.D.C. under M.S.D.E.

M.S.D.E. & N.S.D.C. hold annual Skill Competition to be known as National Level Skill Competition also known as India Skill Competition. The Participant of India Skill will emerge from winner of State Level Skill Competition and subsequently Regional Level Skill Competition. The Winners of India Skill will, through a process of selection, represent India at World Skill and other international Competitions.

<u>Eligibility Criteria</u>: Any skilled person aged 21 and below in the respective year or date provided by D.G.T. can participate in any of the skills mentioned under India skills, with the exception to Aircraft Maintenance, Manufacturing Team Challenge and Mechatronics, where the candidate should be 21 to 23 years of age.

Further, vide letter No. M.S.D.E.-18017/45/2018-TTC(Pt), dated 5th December 2019, competent authority has decided to discontinue the Regional & All India Skill Competition for apprentices and All India Skill Competition for Craftsmen held by D.G.T. to avoid the duplicity of actions for competitions. The D.G.T. will promote the World Skill Competition of M.S.D.E., Government of India so that the trainees of D.G.T. may also get better opportunities at International Level. The Trainees of various institutes of D.G.T. I Government & Private I.T.I.s/Apprentices in establishments irrespective of trade/educational

qualification etc. may participate in this competition only if they fulfill age criteria as per guidelines.
