The Office of the Chief Electoral Officer, Panaji has informed that the Election Commission of India, in exercise of its powers under Article 324 of the Constitution of India, 1950; Section 21 along with other applicable provisions of the Representation of the People Act, 1950 (the "RPA 1950"), and the relevant provisions of the Registration of Electors Rules, 1960 has ordered Special Intensive Revision (SIR) w.r.t. 01.01.2026, as the qualifying date in the state of Goa including other States/UTs(copy enclosed).

The Special Intensive Revision (SIR) in the State of Goa is scheduled to commence from 4th November 2025 to 4th December, 2025. During the Enumeration phase, the BLO's will visit house to house and will issue partially pre-filled Enumeration forms to the electors in duplicate. The previous Special Intensive Revision was conducted by the State in the year 2002.

During the Special Intensive Revision (SIR) all the EROs/AEROs shall ensure that no eligible citizen is left out; and no ineligible person is included.

The BLOs will assist electors in filling the Enumeration Forms and guide them in mapping their electoral details with the 2002 SIR Roll.


However, since the Special Intensive Revision is being conducted in the State after almost 23 years, electors may have doubts about the process involved. Therefore, there is a need for widespread awareness and sensitization among electors regarding the Special Intensive Revision activities.
